- ❖ Sight for Wight requires that prior permission be sought before submitting photographs of private property or gardens.
- ❖ Photos must be genuine; no Photoshop. Entrants remain the copyright holder to any images submitted. Entrants agree to grant Sight for Wight a non-exclusive irrevocable licence to reproduce, enlarge, publish and exhibit for any purpose related to the competition in any medium, including print and digital. This includes, but is not restricted to, exhibiting for use in press and on websites.
- ❖ Winners' photographs and names will be posted on Sight for Wight's website and social media pages.
- ❖ Closing date for entries is Friday 27th September 2019.
- ❖ Winners will be announced in late October 2019.

the photographer agrees that Sight for Wight is not liable.

- ❖ The entrant is responsible for any claim made by a third party against submission.
- ❖ **Disclaimer** - The information given in these Terms & Conditions is correct, but Sight for Wight reserves the right to change any of it without prior notice. By entering the competition, entrants will be deemed to have agreed to be bound by these Terms & Conditions. Any breach of these Terms by an entrant will void their entry.
